## **INSTRUCTIONS TO ABSENTEE BALLOT APPLICANTS**

1. All applicants must personally complete and sign the statement on the bottom of the other side of this form.
2. Mail or deliver this application to the District Clerk at the White Plains Board of Education, 5 Homeside Lane, White Plains, New York 10605.
3. The application must be received at least seven days before the election if the ballot is to be mailed to the voter, or the day before the election if it is to be delivered personally to the voter.
4. This application is valid only for the election to which it specifically pertains. If you wish to apply for an automatic absentee ballot for all elections, issued to permanently sick and disabled voters, you must apply to the Westchester County Board of Elections, 134 Court Street, White Plains, New York 10601.
